Downtown Development: The Risks and The Rewards

The viability and desirability of urban housing development in Tacoma has been an active issue, if not always a subject for outright debate, for the past fifteen years. Residential development



has been a part—either integral or m e r e l y acknowledged—of each Downtown revitalization component to

come before the scrutiny of CITY CLUB's lunch and dinner programs.

Actual development in this urban field of dreams, through projects such as the Colonial Court Apartments at 7th and Pacific, the Cliff Street Lofts, and Jefferson Square at 23rd and Jefferson, has always proceeded under the gloom of an open question: "if we

build it, will they come?" One of the vanguard of these developments, the McDonald Smith Artist Lofts saw its housing components 100% leased within a month of completion in 1989; yet successor projects have continually faced the uncertainty of whether people would keep returning to live Downtown. It is a situation that makes each new project at least as interesting for the risks involved as for the good it promises to Downtown revitalization.

With new projects currently garnering public attention, CITY CLUB will focus its attention on "The Risks and Rewards of Downtown Residential Development" at its December dinner program. The December 4 gathering will examine the topic in the context of three current projects: The Metropolitan, Thea's Landing, and



McCarver Village. The meeting is planned for 6 p.m. at the University of Puget Sound's Wheelock Student Center.

The program will feature a panel of several speakers. At press time John Wise (The Metropolitan) and Lee Pardini (McCarver Village) had been confirmed. Be sure to make reservations early for this meeting.

promote "The Art of Northwest Living" to tourists and convention-goers.
