# January 29<sup>th</sup> Planning for Crisis Breakfast Managing the Consequences

They've gone and done it again! Your Board of Directors, urged on by the intrepid Program Chair, Dawn, and the enthusiastically vocal Membership Chair, Jan, have decided to start the year by REALLY shaking thing up. We're having BREAKFAST! And not just any breakfast. We're going to have some serious discussion about homeland security with our sausage and eggs.

CITY CLUB, never afraid to tackle the meaty issues, will host Jerry Schneider as the guest speaker. Jerry is the Business Development Manager of New Directions, Inc, (NDI) a rapidly growing Department of Defense contractor headquartered here in the South Puget Sound.

NDI and its staff are working on applying technology to assist communities in responding to attacks resulting in mass destruction. They're developing an automated handbook, per se, that will cover as many contingencies as possible. Task forces whose responsibility it is to plan how to meet a crisis situation can use this model to best utilize their available resources. Those resources range from the obvious: fire department, police force, hospitals, and National Guard; to the not-so-obvious:

local construction companies, volunteer organizations, theater owners, and churches. Jerry will discuss some of the many things that need to be considered when planning to meet a crisis and how best to manage the consequences of the decisions made. Recently returned from a homeland security conference in our nation's capital, Jerry will have some insight to share with us.

This meeting, which includes a hot breakfast buffet prepared by Landmark's award winning culinary staff, builds on the discussion at the January 22nd Roundtable. Tom Valentine, Chairman of the Board, and Carrie Cirrito, Executive Director, of the Pierce County Red Cross will discuss what they learned at their recent crisis response conference in Washington, D.C. Plan on attending both of these important meetings.
