# **Tacoma's Newest Tourist Attraction**

The Puyallup Indian Tribe has embarked on a massive project that will transform the portal vistas of Tacoma, add considerably to the tribe's involvement in the entertainment industry, and impact the city's identity as a tourist destination. The \$200 million project is now under way on the south side of Interstate 5; the Tribe is already working with both the City of Tacoma and the Department of Transportation on issues around utilities and infrastructure. Demolition of the Cushman Hospital is scheduled to get under way in January of 2003.

Going up in its place will be a 12-storey, 250-room hotel, with a dozen restaurants, and the largest Tribal casino on the west coast—all designed with a northwest flavor, featuring a lake and waterfalls. The project also includes a 2000-seat entertainment arena and a 600-seat theatre that will feature Las Vegas-style entertainment.



On November 6, CITY CLUB will examine the multi-faceted project, its relationship to Tacoma, and the objective and long-term goals of the only Urban Tribe in America—the Puyallup Indians. Three representatives of the tribe will speak at the November dinner program, slated for 6 p.m. at the Wheelock Student Center at UPS.

Scheduled for the podium are: Puyallup Tribal Chairman Bill Sterud, discussing tribal philanthropy; Frank Wright, Emerald Queen Casino Manager, talking about casino operations; and Tribal spokesperson John Weymer, who will talks about the resort project.

Make plans to attend this program and learn about the impacts this will have on the Greater Tacoma area.

While major changes in technology, global economics, and information systems continue to change e d u c a t i o n a l paradigms, acute and

localized challenges tug at the institutions that shape and live by those paradigms. How, for instance, do our universities continue to evolve to meet the demands of both students and the job market, while coping with a shaky economy and narrowing budgets? In times like these, how do our state's prominent public universities set priorities? What are those priorities, and what changes in priorities should we expect?.

CITY CLUB will explore the present and future of our universities on November 20, when the presidents of Washington State University and The

University of Washington are featured speakers at the monthly luncheon program. Dr. V. Lane Rawlins of WSU and Dr. Richard L. McCormick of UW will speak at noon at the Sheraton.

Rawlins assumed office as WSU's ninth president in June of 2000, after serving a decade as president of the University of Memphis. His relationship with WSU began in 1968 when he joined the faculty of the Department of Economic, and he served as department chair and vice provost there before joining the University of Alabama system in 1986. An Idaho native, he is a graduate of Brigham Young and earned his doctorate from Berkeley.

McCormick has served as UW president since September of 1995, after serving as provost and vice-chancellor at the University of North Carolina at Chapel Hill. A New Jersey native, he is a graduate of Amherst

College and earned his Ph.D. in history from Yale. He began his teaching career at Rutgers, serving as Chair of the Department of



History and Dean of Arts and Sciences before moving on to Chapel Hill in 1992.
